ANNUAL REPORT AND ACCOUNTS

Terry Mitchell presented the annual accounts. As agreed by the PCC £15,000 was moved to support the roof repairs.

Ann Warr proposed the acceptance of the accounts, seconded by Richard Link and carried nem con.

Terry was then thanked for all his hard work on the accounts and reports.

APPOINTMENT OF INDEPENDENT EXAMINER

It was proposed by Terry Mitchell, seconded by Richard Tweed, and unanimously agreed that Chaweevan Williams of Verdant Accountants Limited be re-appointed as the Independent Examiner.

ELECTORAL ROLL

David Williams reported that, in line with Church of England regulations, have revised the electoral roll. We have had 5 people retiring from the roll and 9 people added and so we now have 117 on the roll. The roll had been displayed on the church notice board. The chairman thanked him for his work on the roll.

FABRIC OF THE CHURCH

This last year has been affected by COVID-19 and our preparations to renew the roof. We are missing Chris Greyson following his move to Walton-on-the-Hill but he is still helping us from a distance.

The roof is constructed from sheets of aluminium laid on marine-ply with folds to allow for thermal movement. Unfortunately, the folds between the aluminium sheets were not enough to prevent the roof from leaking during heavy rain and strong winds and as a result the roof has always leaked but luckily it seems the structure of the roof underneath has not been damaged. Following a detailed examination of the roof last year, it has been established that corrosion means these sheets are not securely fixed. There is now the danger that during stormy weather, the whole roof could lift and it is only its weight that prevents catastrophic destruction. Our insurers have informed us that they expect its repair to be done with little delay, as they will not pay out for its repair!

Simon Foster again expressed his heartfelt thanks to all who help in the life of St. Matthew's, and remarked how fortunate the church was to have so many able members of the congregation willing to give their time and skills to its many and varied activities. He thanked everyone for their support over the year. He also thanked Mary – his wife – for her support.

CHURCHWARDEN'S COMMENTS

The wardens remain completely reliant on the commitment of all the loyal and hardworking people for the well-running the church. We could not undertake our duties without the work done by all those who give their time and talents to the life of the church community

Terry miraculously is still our administrator but regularly threatens to resign as the pressures of work increase. We thank him and all those who carry out our Christian mission to Park Hill, especially those who contribute to the Parish Magazine, organise our social events, our fairs, the Christmas Tree Festival, the Floating Shelter and the Food Bank.

Throughout 2019, an aging and reducing army of volunteers worked during services and as team-members on the fabric, finance, kitchen, pastoral needs, social events and communications teams. We have seen some demanding changes in 2020 and hope 2021 will see some recovery of our activities. Michael Strange continues as our excellent director of music, which is an essential element of our ministry and our services. We are performing world premieres of his music.

During 2019, the premises continue to be used by numerous other organisations including the Bach Choir and Croydon Philharmonic, the Alzheimer's help group, Pilates, the U3A, dance groups as well as the Guide and Scout Groups and Archbishop Tenison's School. For most of 2020, these activities have ceased.

Simon our vicar has been through a difficult period in his life and is on the slow road of recovery supported by Mary his wife. He was appointed as the Area Dean and has been supported by Linda Fox, our deputy Area Dean, Richard Hinder and our readers Alison and Paul. Darius, our curate has moved to Holy Saviour in West Croydon. We thank them all for their ministry and pastoral support to all in the parish.

ANY OTHER BUSINESS

Thanks were also given to Jon Highton and the ministry team for all the work on the online services which have been greatly appreciated.

Trustees Annual Report St Matthew's, Croydon Parochial Church Council

The trustees present their annual report and financial statements of the charity for the year ended 31 December 2020. The financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's trust deed, the Charities Act 2011 and Accounting and Reporting by Charities: Statement of Recommended Practice (FRS 102) applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland.

Aim and purposes

St Matthew's Parochial Church Council (PCC) has the responsibility of co-operating with the Incumbent in promoting in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

The vision statement of St Matthew's is:

Sharing the love of God.

The PCC is also specifically responsible for the maintenance of the church complex of St Matthew's and the two church bungalows in Chichester Road, Croydon.

Objects and activities

The PCC, a charity governed by the PCC (Powers) Measure 1956 as amended and Church Representation Rules 2020, is committed to enabling as many people as possible to worship at our church and to become part of our parish community of St Matthew's. The PCC maintains an overview of worship throughout the parish and makes suggestions on how our services can involve the many groups that live within our parish. Our services and worship put faith into practice through prayer and scripture, music and sacrament.

When planning our activities for the year, the Incumbent and the PCC have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance on charities for the advancement of religion. In particular, we try to enable ordinary people to live out their faith as part of our parish community through:

- Worship and prayer; learning about the Gospel, and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- Missionary and outreach work.

To facilitate this work it is important that we maintain the fabric of St Matthew's church complex and the two bungalows.

Achievements and performance

The Vicar

We thank the Revd Simon Foster for all his work in both the church and the community. Revd Richard Hinder, previously our Assistant Priest, who has the Bishop's Permission to Officiate helps on an occasional basis. Revd Darius Weithers, who joined St Matthew's as our new Curate in July 2018 moved to Holy Saviour, Croydon in March, although he remains licensed to St Matthew's. Revd Simon Foster continued as Area Dean and Revd Linda Fox who is licenced to St Matthew's as Assistant Area Dean, took over as Priest in Charge at St George's, Waddon during their interregnum beginning in September 2020.

Worship and prayer

The PCC is keen to offer a range of services during the week and over the course of the year that our community finds both beneficial and spiritually fulfilling.

We welcome families into our church and provide a crèche and classes for children during the Sunday 10:00 am services. The said Eucharist at 08:30 am on Sundays and the Morning Prayer services during the week offer quieter more thoughtful services, while Evensong and Taizé services provide strong musical themes. Special services are held to celebrate the seasons of the church year such as Christmas and Easter. Prayer and bible study and Lent groups are available, offering more informal environments. All are welcome to attend our regular services. During the year we held a number of Healing Services on the first Sunday of the month and All Age Services on the second Sunday. However, due to the Corona virus the church has followed Government and Church of England Guidance and access to the building has been very limited or non-existent. Worship has continued online as have bible study and lent groups and coffee mornings.

As well as our regular services, we enable our community to celebrate and thank God at the milestones of the journey through life. During `the period, we have celebrated two baptisms and one funeral in church and five funerals taken at the crematorium.

Membership and attendance

There were 117 members on the Electoral Roll on 31st December 2020. The average Sunday attendance is eighty five adults and ten children under sixteen years of age.

Diocesan/Deanery Synods

Two lay members of the PCC are members of the Diocesan Synod and three lay members of the PCC are elected members of the Deanery Synod. This provides the PCC with an important link between the parish and the wider structures of the church.

The Church complex

Normally our church is open to the community for worship, prayer, study, social and other functions. We use the facilities to welcome people who are not necessarily regular members of our congregation to events such as Saturday coffee mornings and the shelter for the homeless during winter. The hall and other rooms are used by a wide range of groups as the Community Centre of Park Hill and the wider Croydon community. However, with the rise of the Corona Virus pandemic these were curtailed during the lockdowns.

Our Fabric Team monitors the state of the church buildings and ensures that they are appropriately repaired and maintained. During the period, the main work that has been carried out on the church complex included the updating the lighting in the church and investigation by professionals into the state of the church roof – more details are contained in the Fabric Committee Report.

Pastoral care

During the year our Saturday coffee mornings have continued to provide a meeting place for the community – virtually throughout the Corona virus pandemic. The reserved sacrament is taken to communicants in local care homes. Regular parcels of food and toiletries collected through the "Lord's Larder" were sent to the West Croydon Refugee Day Centre. St Matthew's hosted Croydon Churches Shelter for the Homeless.

Mission and evangelism

The small committee that St Matthew's set up to consider the future giving for mission and evangelism recommended that St Matthew's continued to support the Egyptian Diocesan Association. We have made a donation for the development of teaching for young people within Egypt. We continue to pray for that country.

Volunteers

We would like to thank all the volunteers who work so hard to make our church the lively and vibrant community that it is. In particular we want to mention our Churchwardens Rohini Abhayaratne and Stephen Collingwood who have worked tirelessly on our behalf. While there are too many people to name everyone individually, Terry Mitchell must also be mentioned and thanked. As can be seen from this report, his work as Treasurer is an onerous one, and he has done it with great thoroughness and care. David Williams has continued as PCC Secretary and Electoral Roll officer and Steve Tucker has continued as Magazine Editor and is a member of the Communications Team. Jon Highton has been instrumental in his production of online services during the pandemic.

The bungalows are let commercially and we receive a regular monthly rental from both. They are managed by a local Estate Agent on our behalf.				

In 2016 Southwark Diocese is changed the way that parishes provide funds. Instead of a quota system they moved to the Parish Support Fund where parishes pledge money. St Matthew's traditionally had given the diocese more money than it receives and this has now changed, in part due to providing housing for a curate. St Matthew's pledge for 2020 was gratefully received by the diocese after discussion with the Archdeacon.

Reserves Policy

At 31 Dec 2020 the PCC's reserves were: unrestricted reserves £146,506 (2019: \pm 169,372) designated fund £73,766 (2019: \pm 58,666) endowment fund £800,000 (2019 \pm £800,000); restricted fund £28,398 (2019 \pm £7,277). The PCC has free reserves, comprising unrestricted funds, less fixed assets of £141,327 (2019 \pm £155,357). The PCC has agreed a policy of maintaining a minimum reserve of cash, so that we can pay our bills as they arrive and to provide a cushion against any unexpected expenses. If the cash balance falls below £75,000, (agreed by PCC) no avoidable expenditure will be undertaken until the reserve has been restored.

Endowment Policy

The investments held are two freehold properties and cash and short term deposits. The Freehold properties are valued on an annual basis. Trustees having regard to the liquidity requirements hold surplus funds on short term interest bearing deposit accounts set to achieve a rate of return at least equal to the cost of living increase as measured by the retail price index. Due to wider economic circumstances, deposit rates have been depressed and so this aim was not achieved. The investment funds held on deposit achieved an average rate of 0.5% compared to the retail price index of 1.2%.

Risk Management

The principal risks faced by the PCC are concerned with ensuring that the Health and Safety, Employment and Safeguarding of Adults and Children's policies of the Church are maintained. We also through the Finance Team ensure that all aspects of the finances of the church are dealt with in compliance with the rules of the Charities Act, SORP and Charity Commissioners. The Fabric Team reviews the repair and maintenance of both the church and the bungalows. All policies are reviewed by the PCC on a regular basis.

Plans for the future

The decision-making of the PCC is shaped by our Mission Action Plan (MAP). A Mission Development Group has met with the aim of seeking ways we can more effectively reach out to the community.

Structure, governance and management

The method of appointment of PCC members is set out in the Church Representation Rules. At St Matthew's the membership of the PCC consists of our Vicar (Incumbent),

Churchwardens, Readers, SPAs and members elected by those on the electoral roll. The Treasurer is ex-officio member and the Secretary is an elected lay member. All those who attend our services are encouraged to register on the electoral roll.

The PCC members are responsible for making decisions on all matters of general concern and importance to the parish including how the funds of the PCC are to be spent.

The full PCC met 9 times during the year, with an average attendance of 75.5% and the Standing Committee m et once. Given its wide responsibilities the PCC has a number of committees, each dealing with a particular aspect of parish life.

These committees are:

The Standing Committee, which is the only committee required under church law and is empowered to conduct the business of the PCC between meetings.

The Finance Team, which monitors our income and expenses, makes recommendations to the PCC concerning significant items and matters of policy. The Fabric Team, which advises and oversees all matters relating to the buildings and grounds. This spawned the Roof Team to consider matters related to replacing the church roof.

The Pastoral Team, whose objectives include hospitality, visiting the sick and bereaved and arranging events for the elderly and housebound.

The Social and Fellowship Team organizes a wide range of events with the aim of bringing fellowship and enjoyment to the community of St Matthew's.

The Fundraising Team organizes a wide range of events with the aim of raising funds for St Matthew's.

The Communications Team handles publicity and communications with the community and more widely through our website www.stmatthew.org.uk

The All-Age Worship Team organises the all-age worship services of St Matthew's.

The Young Church Leaders Team handles worship for the young of the parish.

All these teams report regularly to the PCC.

PCC membership

Members of the PCC are either ex-officio, elected by the Annual Parochial Church Council Meeting, or co- opted in accordance with Church Representation Rules. During the year, the following served as members of the PCC:

The accompanying notes form part of these financial statements

1. Accounting policies

a. Accounting convention

The financial statements have been prepared in accordance with the current Church Accounting Regulations together with applicable accounting standards and the Charities Statement of Recommended Practice FRS 102 (effective 1 January 2015.

The financial statements have been prepared under the historical cost convention and under the going concern basis. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their affiliation to another body, nor those which are informal gatherings of church members.

b. Funds accounting

Funds held by the PCC are:

Unrestricted funds - general funds which can be used for PCC ordinary purposes.

Designated funds - monies set aside by the PCC out of unrestricted funds for specific future purposes or projects.

Restricted funds - a) income from trusts or endowments which may be expended only on those restricted objects provided in the terms of the trust or bequest;

b) donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of the year is carried forward as a balance on that fund.

Endowment funds - funds the capital of which must be maintained; only income arising from the investment of the endowment may be used, either as restricted or unrestricted funds, depending on the purpose set out in the terms of the original endowment.

c. Incoming resources

All incoming resources are accounted for gross.

Donations and legacies

Collections are recognised when received. *Planned giving* receivable is recognised only when received. *Income tax* recoverable on Gift Aid donations is recognised when the income is recognised.

Grants and legacies are recognised when the PCC is legally entitled to the amount due, and an inflow is probable.

Income from investments

Interest is accounted for as it accrues.

All other income

All other income is recognised when it is receivable.

Gains and losses on investments

Realised gains are recognised when the investments are sold. Unrealised gains and losses are accounted for on revaluation at 31 December each year.

d. Resources used

Resources expended are accounted for on an accruals basis and are accounted for gross.

Church Activities

The diocesan parish contribution is accounted for when due. Any parish contribution unpaid at 31 December is provided for in these accounts as an operational (though not a legal) liability and is shown as a creditor in the balance sheet.

Support Costs

Support costs are allocated to church activities within the SOFA

e. Fixed Assets

Tangible fixed assets

Consecrated and beneficed properties of any kind are excluded from the accounts in accordance with the Charities Act 2011. All such expenditure is written off as it is incurred.

Movable church furnishings held by the Vicar and Churchwardens on special trust for the PCC and which require a faculty for disposal, are accounted as inalienable property unless consecrated. They are listed in the church's inventory which can be inspected. For inalienable property acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the accounts. Individual items acquired since January 2000 have been capitalised in the accounts and depreciated over their useful economic life.

All expenditure on consecrated or beneficed buildings and individual items under £4,500 are written off in the year they were incurred.

Depreciation

Depreciation is calculated to write down the cost of tangible fixed assets, over their expected useful lives. The rates generally applicable are:

Plant and Machinery	10% straight line
Fixture, fittings and equipment	10% straight line

f. Investment Property

In accordance with the SORP, the Church's freehold are held for long-term investment and are included in the balance sheet at their open market value. The surpluses or deficits on revaluation of such properties are transferred to the endowment fund. Depreciation is not provided in respect of freehold investment properties.

Fabric Report

The building has not been used a great deal this year so there has not been much wear and tear. Unfortunately, the leaks from the roof continue unabated which damaged the flooring in the main foyer and has been repaired by Simon Roberts.

Our underground drains taking waste from the church building and the bungalows have been cleared, revealing damage from tree roots and rats in the inspection chamber near the footpath in Chichester Road. This will need addressing during 2021.



Our boundary wall behind our bungalow at 3 Chichester Road collapsed as a result of damage from a tree growing beside the wall. Work to rebuild the wall starts early 2021.

There have been improvements to the hearing loop in the church and we would like to install a ceiling mounted screen to display services.

Luckily, we do not have a great deal of costly work to be done following our quinquennial inspection except works relating to the roofs and gutters. Jan Williams repaired our bell-ringing rope, which will be good for the next fifty years.

It is our plans for the renewal of the roof that overshadowed 2020. We have agreed the levels of insulation in the renewed roof and the possible installation of solar panels. We will be pressing the DAC to accept the use of an elastomeric covering as a cheaper and more durable material than a metal covered roof. Financing the roof will probably continue for many years after it has been installed.

We do look for another member to join our small fabric team. It is a group that achieves tangible results, which is very satisfying.

Deanery Synod Report

The Croydon Central Deanery Synod met on 26 November 2020, and 9 February 2021. The meeting scheduled to take place on 17 June 2020 was cancelled due to the Covid-19 pandemic.

Our guest speaker at the November meeting was Raewynne Whiteley, Director of Discipleship and Lay Ministry, with a particular brief to develop authorized lay ministries in response to the Lay Leadership & Lay Ministry Advisory Group's report.

What we do as the church is to gather people together whether it's into our building or in another space, and go through a process of transformation where our hearts, minds and actions are transformed to live our identity and our purpose as followers of Christ. This happens through worship, time together, and education processes. We are transformed by our own service through outreach and stewardship, etc. All those things contribute to shaping us in the images of Christ. We are then sent into our families, work lives, society and into the church.

The Lay Ministry Data Project was a survey of Dioceses trying to write down the people involved in all sorts of roles. It found there are approximately 100,000 people engaged in some form of Lay Ministry across the country and almost 90% are on a voluntary basis. These range from administrators to worship leaders.

About a month ago, a report on the idea of vocation called Kingdom Calling was published. There is a tendency for people to think about vocation as a calling that just happens to clergy. But in fact every one of us is called, and there is a diversity of ministries that are important.

Our theme for February's meeting was Christian Perspectives on Secondary Education and Richard Parrish, Headteacher of Archbishop Tenison's school in 2005 was our speaker.

There has been a huge shift in Croydon since then and many improvements have been made. Simon remarked that it's good we have given Richard the opportunity to speak to us because it has allowed him to express the value for the faith schools we have and what we do. We have lost St Andrews and Virgo Fidelis; now Archbishop Tenison's remains the only faith school in the borough. The school is responding by increasing their planned admission number to 150 from next September. 60% of those places will be foundation places. 20% will be given to the 10 Church of England primary schools in Croydon and Sutton, and the remaining 20% will allocated to those geographically close to the school.

The 300th anniversary of Archbishop Tenison's has given them the opportunity to look closely at the school curriculum. The next step is the quality of teaching, and then pupil learning. There has been great emphasis on finding specialist teachers rather than an existing teacher who can merely "fill-in". 90% of what they do is the same as every other school, so what does the faith side do and how does it make a difference? The Church of England nationally has come up with an answer about a Christian vision which can be summarized in four words:-

- Community
- Wisdom
- Dignity
- Hope

Richard likened the other 10% to the parable of the leavened bread. The prayer at the start of each day, the collective worship the pupils have and looking at the Scriptures in leadership team meetings make a disproportionately huge difference to the life of the school. Their vision can be summed up in five different areas:-

1. We learn together and the people of God are one people.

2. Tremendous work is put into those who are disadvantaged. It is important to educate the whole person; mind, soul, body and spirit.

3. Each segment of the curriculum is given an equal importance.

4. Teach in a human way. We need to take into account where our pupils come from and what their home circumstances are. It's important for young people to have the space to regulate themselves in the classroom.

5. Our processes and attitudes are equally important. It's not just about outcomes.

So how do we together in our churches help to create a climate where this vision is talked about and valued? How does the church engage with government and society? Author and academic Leesa Wheelahan, talks about the importance of trust underpinning any real learning. Psalm 37 talks about anxiety; "Do not fret it leads only to evil". And so as the church, we have something to say about trust in God and one another as the basis for people to thrive and succeed. The future is really the present continued.

The Bible talks about being reborn; Richard emphasizes to his staff that they must be ready and willing to embrace change.

In conclusion, the church more than ever has a great opportunity to contribute to the educational thinking in this country and those of us who work in schools are continuing to work out what that means. But it needs the church more widely to tell them what it means to be human and we have to work out how we do this in schools.

Richard thanked the Synod for the invitation to speak, and also for the various ways we have supported the school both through prayer and practical support over the years.

Our next Deanery Synod will be on Thursday 17th June 2021 at 8pm. The theme will be 'Dementia Friendly Church' and our guest speaker will be Andy Gilbert from the Prama Foundation. The meeting will be held on Zoom.

Roof Fund raising committee

This committee was set up in April 2020 – It's aim being "To secure funding for the repair of the roof of St Matthew's church". It reports in to the Fabric team, which is managing the roof repair project.

With lockdown having just started the normal idea of fund raising events based on socialising and enjoyment to creating funds was not going to be possible. We have a challenging amount to raise rounded up it is £500K, which is a lot of money. The amount

was identified by architects who had investigated the problems with the roof and come up with options for the repair and the PCC in December 2019 decided on the approach they wanted to take.

The committee began by creating a very stylish donation form thanks to the help of Richard Hinder. This was distributed to all members of the congregation. All advice was that those who use and benefit from the church would be the ones to most likely to make donations towards the repairs. We had been very fortunate that we began with monies from some legacies left by members of the congregation in their wills.



The times were very difficult for everybody so to ask for money in

uncertain times is difficult but fortunately the congregation realised that we had to help ourselves if we want to save the church. The Diocese would not be giving us any money nor was the National Lottery fund which had in the past been a good source for this sort of cause. Somehow the money started to come in and by December the amount totalled £83,415.99. Terry particularly likes to keep and report on the 99p!

We have drawn up a list of trusts to whom we could apply for funds but most required that we had reached certain criteria before they would consider an application, These application forms are several pages long and require a great deal of information. Some obvious sources of funding were looking to support those having difficulty during the COVID crisis and not giving for building or repair projects so we have had refusal to our applications.

We created a questionnaire for those who regularly rented space in the building asking if they planned to return when things got back to normal and whether they could make a donation. We also wanted to know if we could use their details when appealing to trusts. During the summer we worked with some of the groups on their risk assessments to enable them to return in the middle of the year.

The work goes on in 2021 and we still have a long way to go - all contributions will be gratefully received.

1st Croydon (St Matthew's) Scouts

This past year for the Scouts has, like the rest of the country, been a particularly hard year. The last face-to-face meeting we held was in mid-March 2020, and since then our scouting has been entirely virtual. We finished the spring term by creating activity sheets for the Scouts to carry out. These included games, badge work, quizzes, tasks from the TV series Taskmaster, and activities provided by the Scout Association.

We were fortunate enough to receive a Zoom account, arranged for by the Scout Association, which meant that for a good deal of the summer we were able to meet virtually. The leaders arranged for the Scouts to take part in a wide range of activities, many



that would help with scouting knowledge. We quickly realised that, although the Scouts may have been attending school in some form, they were missing the contact that they were used to having with their friends. Therefore we made the decision that throughout the summertime the scout sessions would be primarily focused on fun activities that would enable the Scouts to interact with each other. We also took part in two

virtual camps. One was an overnight camp, where the Scouts and leaders cooked an evening meal, told stories round a virtual campfire, and created dens indoors to sleep in. The second was organised by the Scout Association, and included a camp opening and closing ceremony held by Bear Grylls, many fun activities, a campfire streamed live from Gilwell Park, and a bedtime story told by a children's author amongst many other things. More recently we have been doing such things as first aid and cooking over Zoom. One of the Scouts even took part in the district bake off and received a badge and certificate. One particular activity that we have found to work well is virtual escape rooms as it gives the opportunity for everyone to take part at the same time.

There was a very brief opportunity for the Scouts to start meeting face-to-face at the end of last year, however further lockdowns meant that we didn't get around to doing so. More recently the Scout Association has started allowing face-to-face meetings to start happening again. For obvious reasons there is quite a bit of paperwork that the leaders have to complete first, but we are hoping that we will be back doing so as soon as possible, although it is envisaged that we will start off meeting outdoors before moving back to indoor activities in the Autumn term.

1st Croydon (St Matthew's) Beaver Scouts

During Lockdown I quickly started running Beavers online using Zoom (30mins each week). On one hand it gave me the freedom to do activities we wouldn't normally be able to do at the hall (backwoods cooking, making a trebuchet/slingshot using pioneering, etc.) but equally I had to come up with ideas of what we could make and do with just the materials parents had at home. Although numbers are low (some children did not cope well psychologically with Zoom or lockdown and sadly they simply withdrew from Scouting), those attending do so regularly and clearly enjoy the activity programme a lot. Upon request I continued running Beavers throughout the Easter & May half-term holidays and into the summer holidays – 5 months of non-stop Scouting (including two online investitures)!

Leaders Tic Tac Beaver and Cycling Beaver continue to be assisted in 2019 by Swimming

Beaver who has now completed his Silver Duke of Edinburgh (DoE) award as our Young Leader; he's now taking a break due to GCSE exams looming (summer 2021) but we may have another DoE volunteer helping out for 3-6 months (November 2020 onwards). With our parent helpers we continued to learn Skills For Life, hold termly Log Chews (You-shaped Scouting) and have Fun and Friends. In 2020 TicTac Beaver will be hanging up her scarf after many years (decades!); we are delighted that she will continue Scouting as an Occasional Helper.



In 2021 we hope to again try school assemblies for Founder's Day (22 Feb) or St George's Day (23 April), as well as stalls at any school fairs. We also hope to mount an online recruitment campaign but we need *more adult volunteers* to be able to cope with a surge in membership. So if you have enjoyed your time helping at Beavers (on the parent rota) or have any specific skills you can bring to Scouting (web design, marketing, project management, cooking, DIY, gardening, etc.), please consider becoming an Occasional Helper; this merely means you're helping more than once a month, so how regularly you help is up to you. Getting dressed up in RNLI kit is optional!
